- 1 Player to use the facility must hold valid membership of Canadian Chinese Table Tennis Association (CCTTA), or purchase a \$70 Ten-Entry Pass or purchase a \$8 Visit Pass.
- 2 All players, members, and non-members alike, must obey CCTTA rules and cooperate with official and other players.
- 3 Any player failing to comply with CCTTA regulations will be warned.
- 4 Repeat offenders will be asked to exit the playing area and his/her membership will be terminated immediately with no refunds.
- 5 The Board of Directors has the exclusive right to accept or decline membership applications.
- 6 Site and play time may change at the discretion of CCTTA. Members will be notified in advance.
- 7 CCTTA reserved all rights to close all or any part of court for events hosted by CCTTA with notice in advance.

RELEASE AND WAIVER
